The Saint-Ouen l'Aumône facility employs around 80 people, with annual sales of approximately 15 million USD. It operates a "state of the art" facility, equipped with significant special coatings, brazing, welding & machining capabilities. The site has recently invested in additive manufacturing capabilities and is progressively qualifying new repairs with this technology.

It also has invested into significant thermochemical furnaces installations, allowing super alloy coating depositions of multiple kinds, a process which is NADCAP certified.
